

Culvert Permit

We are sending you a culvert permit per a request. We will size the culvert after you have flagged the area, then we will contact you to let you know what size culvert you need to purchase. We will set the culvert and back fill with crushed rock with no charge. However, we do require the landowner's signature on the enclosed permit. You may sign and return the permit to our office so that we may send someone out to determine the size. After the permit has been received, and the area staked/flagged, we will then go and size the area.

We will contact you with the proper size of the culvert to be purchased by you. The diameter must be as we determine, and the length we determine shall be the minimum length. It is usually in the property owner's best interest to go longer in the length, due to the fact we will only set the culvert ONCE. Remember **any future changes are at your own expense.**

After the purchase has been made we will contact the supplier for delivery. We do like to inform you **we do not pick up culverts.** We provide a list of the local suppliers who work with the county in the delivery of the culvert.

Please inform our office once the area has been staked, and the permit has been sent to our office.

**PERMIT TO CONSTRUCT ACCESS DRIVEWAY
ON COUNTY RIGHT OF WAY**

Dear Grantee:

The Washington County Road Department will set a culvert on the below mentioned property and hereby authorizes you to construct a driveway on the county right of way for development of access to your property in Washington County adjoining County Road: _____ Provided you agree to and comply with the following conditions;

1. All driveway pipes shall be corrugated Galvanized Metal Pipe of size and length determined by the County Representative, and to be purchased by the Owner *. The purchase price should include delivery; **THE COUNTY DOES NOT PICK UP CULVERTS.**
2. Maintenance of driveway constructed hereunder shall be the responsibility of the grantee, and the Washington County Road Department reserves the right to require changes, maintenance or repairs as may be necessary to provide protection of life or property on or adjacent to the county road.
3. The grantee shall hold harmless Washington County and it's duly appointed agents and employees from any action for personal injury or property damage sustained in the installation of this driveway.
4. **Washington County will set the culvert only ONCE! Any future changes necessary will be at the owners' expense, either by private contractor or county fee structure.**

The Washington County Road Department will assist as follows: Install and back-fill culvert and place gravel over pipe out to the right of way line.

* **When installing a culvert over 30' in length, the grantee does hereby accept full and total responsibility for keeping culvert clean and clear of any and all obstructions that would prevent the water from flowing freely. If the property where the culvert is placed transfers ownership, it is the grantees responsibility to advise the new owner of this agreement and have them sign a like agreement.**

** **Once concrete is placed over the culvert the maintenance of this culvert becomes the full and total responsibility of the grantee. The grantee must keep the culvert open and free flowing. If at any time the county must remove the culvert it will be the responsibility of the owner to replace the culvert.**

This permit shall not be valid until grantee signs the statement in which he agrees to comply with the conditions herein.
