



# PROCLAMATION

BY THE

## Governor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME:

WHEREAS, I, GREG ABBOTT, Governor of the State of Texas, issued a disaster proclamation on July 8, 2022, as amended and renewed in a number of subsequent proclamations, certifying that exceptional drought conditions posed a threat of imminent disaster in several counties; and

WHEREAS, the Texas Division of Emergency Management has confirmed that those same drought conditions continue to exist in these and other counties in Texas, with the exception of Anderson, Armstrong, Bailey, Bastrop, Baylor, Brazoria, Brazos, Brewster, Burleson, Cochran, Collin, Cooke, Crane, Crockett, Dallas, Delta, DeWitt, Donley, Ector, Edwards, Ellis, Fannin, Fayette, Fort Bend, Freestone, Galveston, Goliad, Hockley, Hopkins, Hunt, Irion, Jackson, Johnson, Karnes, Kaufman, Knox, La Salle, Lamb, Lavaca, Lee, Limestone, Live Oak, Loving, Madison, Matagorda, McMullen, Midland, Milam, Montague, Navarro, Oldham, Parker, Pecos, Presidio, Rains, Randall, Red River, Reeves, Refugio, Roberts, Robertson, Rockwall, San Jacinto, Stonewall, Sutton, Tarrant, Terrell, Trinity, Upton, Val Verde, Van Zandt, Victoria, Walker, Waller, Ward, Washington, Webb, Wharton, Wichita, Wilbarger, Wilson, Winkler, and Zavala counties.

NOW, THEREFORE, in accordance with the authority vested in me by Section 418.014 of the Texas Government Code, I do hereby amend and renew the aforementioned proclamation and declare a disaster in Andrews, Aransas, Atascosa, Austin, Bandera, Bee, Bell, Bexar, Blanco, Borden, Bosque, Briscoe, Brown, Burnet, Caldwell, Calhoun, Callahan, Cameron, Castro, Childress, Coke, Coleman, Collingsworth, Colorado, Comal, Comanche, Concho, Coryell, Cottle, Crosby, Dallam, Dawson, Deaf Smith, Dickens, Dimmit, Eastland, Erath, Falls, Fisher, Floyd, Foard, Frio, Gaines, Garza, Gillespie, Glasscock, Gonzales, Grimes, Guadalupe, Hale, Hall, Hamilton, Hansford, Hardeman, Hartley, Hays, Henderson, Hidalgo, Hill, Hood, Howard, Hutchinson, Jones, Kendall, Kent, Kerr, Kimble, King, Kinney, Lamar, Lampasas, Leon, Llano, Lubbock, Lynn, Martin, Mason, Maverick, McCulloch, McLennan, Medina, Menard, Mills, Mitchell, Montgomery, Moore, Motley, Nolan, Ochiltree, Palo Pinto, Parmer, Polk, Reagan, Real, Runnels, San Saba, Schleicher, Scurry, Shackelford, Sherman, Somervell, Starr, Stephens, Sterling, Swisher, Taylor, Terry, Tom Green, Travis, Uvalde, Willacy, Williamson, Yoakum, and Zapata counties.

Pursuant to Section 418.017 of the Texas Government Code, I authorize the use of all available resources of state government and of political subdivisions that are reasonably necessary to cope with this disaster.

Pursuant to Section 418.016 of the Texas Government Code, any regulatory statute prescribing the procedures for conduct of state business or any order or rule of a state agency that would in any way prevent, hinder, or delay necessary action in coping with this disaster shall be suspended upon written approval of the Office of the Governor. However, to the extent that the enforcement of any state statute or administrative rule regarding contracting or procurement would impede any state agency's emergency response that is necessary to protect life or property threatened by this declared disaster, I hereby authorize the suspension of such statutes and rules for the duration of this declared disaster.
