- An additional fee of fifty (\$50.00) dollars per hour/per officer will be charged to the plaintiff on civil action on all writs exceeding one hour.
- Pursuant to Local Government Code Section 118.131 and Attorney General Opinion JM-1046 (1989), the expenses for providing the services incident to unsuccessful service of process are equal to or exceed the expenses of actual service and the fee is thus set at the same cost charged for actual service.
- Constable's Commission due based on percentage of all monies collected on Writs of Executions or Orders of Sale: 10% up to and including \$10,000.00 and 6% for amounts over \$10,000.00. Tax sales held are not subject to any additional commission. The percentage based on amount collected, not the amount of the judgment.
- When the money is collected by the officer without sale, one-half (1/2) of the above rates shall be allowed.

It is further ordered that notice be given as required by Section 118.131
 Local Government Code and that notices be posted as prescribed by Section 81.007 Local Government Code.
