REQUEST FOR QUALIFICATIONS (RFQ)

OUTSIDE AUDIT SERVICES

I. INTRODUCTION

Washington County, Texas (the "County") is soliciting Requests for Qualifications ("RFQs") from qualified certified public accounting firms to perform the County's annual financial audit in accordance with applicable standards and regulations. The County currently maintains its financial records on a cash basis and utilizes a financial consultant to convert records to modified accrual for year-end financial reporting. This engagement will cover the audit for fiscal year 2024, with the option to extend the engagement for additional fiscal years by mutual agreement, not to exceed 5 years.

II. SCOPE OF SERVICES

The selected firm will be expected to perform the following services:

- 1. Annual Audit of the County's financial statements, including any required Single Audit(s) under the Uniform Guidance, if applicable.
- 2. Review and evaluate the County's converted modified accrual financial statements and related schedules.
- 3. Express an opinion on the fair presentation of the financial statements in accordance with generally accepted accounting principles (GAAP).
- 4. Issue a management letter identifying any material weaknesses, significant deficiencies, or other findings, with recommendations for improvement.
- 5. Attend meetings with the County Auditor, Commissioners Court, and/or consultant, as needed, to present findings and respond to questions.
- 6. Coordinate with the County's consultant who performs the cash-to-modified accrual conversion to ensure audit readiness and data accuracy.

III. COUNTY INFORMATION

- Fiscal year end: December 31

- · Budget is cash basis, monthly and annually

- Fund types: General Fund, Special Revenue Funds, Debt Service, Capital Projects, Custodial Funds and various Grant Funds

IV. MINIMUM QUALIFICATIONS

- · Licensed CPA firm in the State of Texas
- · Demonstrated experience auditing Texas counties or similar local governments
- Familiarity with Governmental Accounting Standards Board (GASB) requirements
- No conflict of interest with Washington County operations

V. SUBMISSION REQUIREMENTS

Each RFQ must include the following:

- 1. Firm background and qualifications, including government audit experience
- 2. Team members assigned to the County's engagement and their relevant credentials
- 3. References from at least three governmental entities (preferably Texas counties)
- 4. Proposed timeline for audit fieldwork and report issuance
- 5. Proof of insurance, including professional liability coverage
- 6. Acknowledgment that this is a Request for Qualifications (not a Request for Proposals), and that no pricing is to be included in the submission

VI. SELECTION PROCESS

Submissions will be reviewed and ranked according to demonstrated competence and qualifications. In accordance with Texas Government Code Chapter 2254 (Professional Services Procurement Act), price negotiations will occur only with the most qualified respondent.

VII. DEADLINE AND DELIVERY INSTRUCTIONS

All RFQs must be received by 10:00 a.m. on Thursday, July 10, 2025. Late submissions will not be considered.
