


NOTICE OF SHERIFF'S AND CONSTABLES' FEES OF  
WASHINGTON COUNTY, TEXAS  
EFFECTIVE JANUARY 1, 2021

On this the 8 day of September, 2020, upon motion made by Commissioner Kirk Hanath, seconded by Commissioner Cardice Bullock the court unanimously approved the following fee schedule for Washington County, Texas, for services by the office of the Sheriff and Constables, effective January 1, 2021, until further Order of the Court, to wit:

- An additional fee of thirty (\$30.00) dollars per hour/per officer will be charged to the plaintiff on civil action exceeding on hour on all writs.
- Pursuant to Local Government Code Section 118.131 and Attorney General Opinion JM-1046 (1989), the expenses for providing the services incident to unsuccessful service of process are equal to or exceed the expenses of actual service and the fee is thus set at the same cost charged for actual service.
- Collecting money on an execution of an Order of Sale, when the same is made by sale, for Five Hundred Dollars (\$500.00) or less, ten percent (10%). For all sums over Five Hundred Dollars (\$500.00), six percent (6%). The percentage is based on the amount collected, not the amount of the judgment.
- When the money is collected by the officer without sale, one-half (1/2) of the above rates shall be allowed.
- It is further ordered that notice be given as required by Section 118.131 Local Government Code and that notices be posted as prescribed by Section 81.007 Local Government Code.


