



Dear Commissioner's Court:

I am currently working on selling/conveying approximately 9.722 acres of my 19.944 acre tract in the Isiah Hawkins Survey, A0057. This division fronts Quarry Rd. and Phillips Ln. in Precinct 3, and is outside the ETJ of the City of Brenham city limits. This property has not been granted a variance of this nature prior to my request, of which I do understand it is my responsibility to determine.

The division of the subject property will be accessible by a minimum road frontage of 250 feet for each tract fronting Quarry Rd. and Phillips Ln.; water will be supplied by a water well; and shall be serviced by an on-site sewage system. 


Dear Commissioners' Court,

We are currently working on selling approximately 7 acres out of our 10.0932 acre tract in the Daniel B. Friar Survey, A-0042. This property is in Precinct 4 and is outside of the ETJ of any city limits. To the best of our knowledge this property has not been granted a variance of this nature prior to our request, of which we do understand it is our responsibility to determine. Please see attached aerial drawing of proposed boundary lines.

The tract and the property to be retained will exceed the County's minimum requirement of 60' of frontage, with frontage on Lewis Road to be approximately 100.70' per existing survey also attached. 




CRIMES REPORTED





BURGLARIES/THEFTS






TRAFFIC CITATIONS/WARNINGS/CRASHES





ARREST BY AGENCIES






AVERAGE DAILY POPULATION

JAIL BOOKINGS BY GENDER




CALL RESPONSE TO CITY OF BURTON





2026 Revenue by Month




AVG DAILY REVENUE



Revenue by Docket


